Insurance Market Reforms

- Reduced cost-sharing for individuals enrolling in qualified health plans (§1402) (CCA, MassHealth) (*MHCCA WG*)
- Procedures for determining eligibility for Exchange participation, premium tax credits and reduced cost-sharing, and individual responsibility exemptions (§1411) (CCA, MassHealth, DOR) (*MHCCA WG*)

Employer Responsibility

Insurance Coverage Expansions

- Expansion to 133% - increased FMAP for newly eligible (§ 2001a) (MassHealth)
- Limited to benchmark coverage (§2001c) (MassHealth, CCA) (*MHCCA WG*)
- Income eligibility for nonelderly determined using modified gross income (§2002) (MassHealth, CCA) (*MHCCA WG*)
- Requirement to offer premium assistance for employer -sponsored insurance (§2003) (MassHealth)
- Permitting hospitals to make presumptive eligibility determinations for all Medicaid eligible populations (§2202) (MassHealth)
- Protection for recipients of home and community-based services against spousal impoverishment (§2404) (MassHealth, ELD, DisbPol) (*LTC/BH WG*)
- Elimination of exclusion of coverage of certain drugs (§2502) (MassHealth)
- Extension for specialized MA plans for special needs individuals (§ 3205) (MassHealth, ELD) (*LTC/BH WG*)

Quality Improvements

- Quality reporting for long-term care hospitals, inpatient rehabilitation hospitals, and hospice programs (§3004) (DPH)
- Quality reporting for PPS-exempt cancer hospitals (§3005) (DPH)
- Imposition of annual fee on health insurance providers (§9010) (DOI)
- Development of standards for financial and administrative transactions (§10109) (MassHealth, MeHI)

2nd Quarter (April 1st – June 30th)

- Enrollment Simplification and coordination with State Health Insurance Exchanges (§2201) (MassHealth, CCA) (*MHCCA WG*)
