

**Patient Protection and Affordable Care Act**  
**Massachusetts Implementation Tasks for Calendar Year 2012**

**1<sup>st</sup> Quarter (January 1<sup>st</sup> – March 31<sup>st</sup>)**

**Transparency/Fraud and Abuse**

- Required disclosure of ownership, including a description of the governing body and organizational structure of the facility and information regarding additional disclosable parties (§6101) (DPH)
- Accountability requirements for skilled nursing facilities and nursing facilities (§6102) (DPH)
- Development of a program for facilities to report staffing information in a uniform format based on payroll data, and to also take into account services provided by any agency or contract staff. (§6106) (DPH)
- Businesses that pay any amount greater than \$600 during the year to corporate and non-corporate providers of property and services to file an information report with each provider and with the IRS. Information reporting is already required on payments for services to non-corporate providers (§9006) (EWG)

**Elder & Disabled**

- Requires the Access Board to establish standards for accessibility of medical diagnostic equipment to individuals with disabilities. (§4203) (DisbPol, DPH) (LTC/BH WG)

**Quality**

- Requires stakeholder input into the selection of quality and efficiency measures. (§3014) (HCQCC)

**Grants & Demonstrations**

- Medicaid demonstration project to evaluate integrated care around a hospitalization (§2704) (MassHealth) (LTC/BH WG)
- Pediatric Accountable Care Organization Demonstration Project (§2706) (MassHealth)
- Medicare shared savings program provides rewards to Accountable Care Organizations (ACOs) that take responsibility for the costs and quality of care received by their patient panel over time (§3022) (MassHealth)
- Demonstration program to integrate quality improvement and patient safety training into clinical education of health professionals (§3508) (HCQCC)
- Creates demonstration programs on oral health delivery and strengthens surveillance capacity. (§4102) (DPH, MassHealth)
- Alternative dental health care providers demonstration project (§5304) (DPH) (HCWF WG)

**2<sup>nd</sup> Quarter (April 1<sup>st</sup> – June 30<sup>th</sup>)**

**Transparency/Fraud and Abuse**

- Requires each manufacturer and distributor of applicable drugs to submit certain information to the HHS secretary. (§6004) (DPH)

**2012, date unspecified**

**Public Health**

- US HHS Secretary to require federal and federally supported health and public health programs/activities to collect and report specified demographic (e.g., race, ethnicity, sex, language, disability, underserved rural and frontier populations) and other data appropriate for health disparities and quality reporting. (§4302) (DPH, MassHealth, CCA, GIC, HCQCC)

**Elder & Disabled**

- Elimination of Part D cost-sharing for certain dual eligible individuals (§3309) (MassHealth, ELD, DisbPol, DMH) (*LTC/BH WG*)

**Federal Fiscal Year 2012 Grants and Demonstrations**

- Medicare Graduate nurse education demonstration project (§5509) (*HCWF WG*) FFY 2012-2015
